A Non-Profit Corporation

Pursuant to the provision of the Nonprofit Corporation Act of this state, the undersigned incorporator hereby adopts these Articles of Incorporation.

Article 1

The name of this corporation is Freeside Technology Spaces, Inc.

Article 2

The corporation is organized pursuant to the Georgia Nonprofit Corporation Code.

Additionally, the purposes for which this corporation is organized are for the purposes as specified in Section 501(c)(3) of the Internal Revenue Code, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code.
